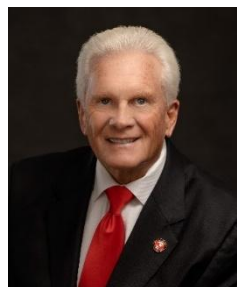

more across diverse cultures and time periods, with signature roles include the Mayor and barroom pugilist in Carmen and the Philistine Commander, Abimélech, in Sampson and Delilah.
